Save our Curlews

Campaign & Appeal



The Birds of Shropshire estimated that the Curlew population declined by 77% between 1990 and 2010, down to around only 160 pairs, and had disappeared from 62% of the area they occupied in 1990. They have continued to decline since, down to below 120 pairs. At the current rate of loss, the population will halve in 12 years, and virtually disappear within 25. There is a real danger that Curlew will become extinct in the County, unless urgent and effective action is taken to save them.

Shropshire Ornithological Society 2005 (SOS 2005)* has committed to support a long-term County-wide *Save our Curlews* Campaign, by providing funding for three years, promoting an Appeal to SOS and Community Wildlife Group (CWG) members, and the general public, hosting banking facilities, and supporting grant applications and other funding requests. The Campaign will continue to undertake nest finding, protecting nests with electric fencing, and radio-tagging and tracking chicks to find out how they use the landscape, and what happens to them. Understanding the reasons for low levels of chick survival is part of the key to an effective conservation plan.

Campaign work also involves ten independent CWGs from across the County, over 300 people who are monitoring about three-quarters of the County Curlew population.

In 2022, project work was carried out in the Upper Clun, Clee Hill and Strettons CWG areas. Nine nests were found. Four were predated, but 18 chicks hatched from the other five, and all were tagged. All except three were predated. The exceptions apparently died of natural causes, surrounded by thick impenetrable silage. This result is even worse than last years, when all except one of 21 tagged chicks were predated. Average survival was less than seven days, a small fraction of the 35 days each chick needs to fledge. We obtained similar results in 2018 and 2019.

More funds are needed for this ground-breaking work. In 2023, it is intended to continue in the Strettons area, and spread this vital conservation work to CWG areas around Oswestry.

The results are sent to the South of England Curlew Forum, the UK and Ireland Curlew Action Group and the Curlew Recovery Partnership for England, so the work is an integral part of the case to Government for effective Curlew conservation measures.

It also describes the overwhelming evidence that predation by foxes and other predators is the main cause of Curlew's continuing decline. It is clear that the annual release of millions of pheasants for shooting, only a third of which are actually shot, results in an over-abundant food supply which maintains the numbers of all the Curlew's main predators at well above naturally sustainable levels. We must continue to produce the evidence and call for immediate action to reduce the release of gamebirds.
